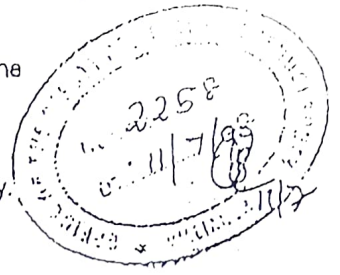

MEMORANDUM

Sub: Revenue -Non-indication of values of temple lands in the Guide Line Register -Instructions - Issued.

Ref: ID Note No.3226/CHRI/T1/2008 dt: 27-06-2008 of the Commissioner, Hindu Religious Institutions, Puducherry.



Complaints have been received that the lands belonging to temples are being attempted to be alienated by strangers without having title over these lands by way of creating bogus documents which may lead to loss of property and income to the temples. The Commissioner, Hindu Religious Institutions has therefore requested this department vide I.D Note referred above to get deleted the indicative value of the temple lands from the guide line registers to prevent any possible fraudulent transactions.

2. The Sub/Deputy Collectors (Revenue) are, instructed not repeat, not to indicate value of the lands belonging to temples as notified by the Hindu Religious Institutions vide G.Os as indicated below (copy enclosed) in the Guide Line Registers.

In case of necessity for alienation of temple lands, on specific request by Commissioner, Hindu Religious Institutions, market value may be assessed by the concerned Deputy / Sub Collector following the method adopted for arriving at the market value of the lands under the provisions of Land Acquisition Act and be communicated to the Commissioner, Hindu Religious Institutions.

3. It is clarified to the Registration authorities that the value shown against the temple lands in the GLR 2008-09 shall be treated as Nil.

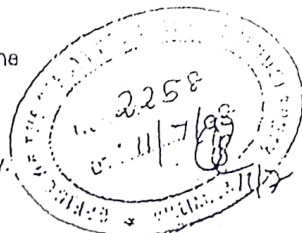

Complaints have been received that the lands belonging to temples are being attempted to be alienated by strangers without having title over these lands by way of creating bogus documents which may lead to loss of property and income to the temples. The Commissioner, Hindu Religious Institutions has therefore requested this department vide I.D Note referred above to get deleted the indicative value of the temple lands from the guide line registers to prevent any possible fraudulent transactions.
